I. BACKGROUND

1. The Meeting of the Disciplinary Committee was called to consider the following two issues, which were deliberated in the following order and terms:

ITEM NO. 1 RECOGNITION OF MEDICAL INSTITUTIONS/COLLEGES

2. It came to the knowledge of the Competent Authority that a number of institutions were previously granted provisional registration without any basis. However, no inspection of these medical institutions has ever been conducted after grant of provisional registration.

6. This Committee is of the view that the Colleges identified in the afore-mentioned list shall be individually evaluated and inspection of the Colleges shall be conducted, afresh. The Committee directs that the Colleges shall be communicated by the education department to be prepared for their inspection within 01 (one) weeks' time on 2019 standards. The future course for admissions shall be based on outcome of the Inspection report.



ITEM NO. 2 REGISTRATION OF STUDENTS IN MEDICAL COLLEGES DESPITE INSTRUCTION OF STOPPED ADMISSION/RECOMMENEDE FOR CLOSURE

7. It has come to the knowledge of the Competent Authority that a number of students of such colleges/institutions have been registered by the PMC which were otherwise stopped from admitting students or there were recommendations of closure for such colleges/institutions.
